1. Information about us

<http://www.mimicbooks.com> is a site operated by Mimic Books Limited (**we or us**). We are registered in England and Wales under company number 06672512 and we have our registered office at Wainstalls Head, Wainstalls, Halifax, West Yorkshire, England, HX2 7TB.

We are a limited company.

2. Accessing our site

Access to our site is permitted on a temporary basis, and we reserve the right to withdraw or amend the service we provide on our site without notice (see below). We will not be liable if for any reason our site is unavailable at any time or for any period.

From time to time, we may restrict access to some parts of our site, or our entire site, to users who have registered with us.
